

## **Integra First Federal Credit Union YETI Giveaway Official Rules**

### **THE ODDS OF WINNING DEPEND UPON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED DURING THE SWEEPSTAKES PERIOD.**

Integra First Federal Credit Union's YETI Giveaway (the "**Sweepstakes**") starts on Thursday, Jan 1, 2026, at 12 a.m. ("CT") and ends on Tuesday, March 31, 2026, at 11:59 p.m. Central Time ("CT") ("**Sweepstakes Period**").

**ELIGIBILITY:** Open only to legal residents of the fifty (50) United States and the District of Columbia, 18 years of age or older at time of entry. Void where prohibited. Employees of Integra First Federal Credit Union ("**SPONSOR**"), and their respective parents, affiliates, subsidiaries, vendors, and advertising and promotion agencies are not eligible to enter or win. By participating, entrants agree to be bound by these Official Rules and the decisions of the judges and/or Sponsor, which are binding and final on matters relating to this sweepstakes. All eligible loan originations must be completed by 11:59 p.m. (CT) on Tuesday, March 31, 2026. Limit one (1) entry per person for the duration of the Entry Period. Entries generated by script, macro or other automated means or means which subvert the entry process will be void. No giveaway pages are allowed to enter the Giveaway.

Loan approval is subject to credit approval and standard lending criteria. Not all applicants will qualify. Applying for or being eligible for the Giveaway does not guarantee loan approval.

There is no alternative method of entry. Entry into the Giveaway is contingent upon applying for a new Integra Cash loan during the Sweepstakes Period.

One (1) winner will be selected in a random drawing held on or about 9 a.m. CT Wednesday, April 1, from all eligible entries received by Integra First Federal Credit Union ("**SPONSOR**"). Odds of winning depend on the number of eligible entries received.

**WINNER NOTIFICATION:** The winner of the Giveaway will be notified on or about Wednesday, April 1, by phone and/or email, and may be required to execute and return an affidavit of eligibility, a liability release and, where lawful, a publicity release within seven (7) days of date of issuance.
