

Integra First Federal Credit Union Credit Union Youth Month Contest and Giveaway Official Rules

THE ODDS OF WINNING DEPEND UPON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED DURING THE SWEEPSTAKES PERIOD.

Integra First Federal Credit Union's Credit Union Youth Month Contest and Giveaway (**the "Sweepstakes"**) starts on Wednesday, April, 2026, at 8 a.m. ("CT"), and ends on Thursday, April 30, 2026, at 11:59 p.m. Central Time ("CT") (**"Sweepstakes Period"**).

ELIGIBILITY: Open only to legal residents of the fifty (50) United States and the District of Columbia, 16 years of age or younger at time of entry. Void where prohibited. Employees of Integra First Federal Credit Union (**"SPONSOR"**), and their respective parents, affiliates, subsidiaries, vendors, and advertising and promotion agencies are not eligible to enter or win. Entries generated by script, macro or other automated means or means which subvert the entry process will be void. No giveaway pages are allowed to enter the Giveaway or Contest. WINNER NOTIFICATION: The parents or guardians of the Contest and Giveaway winner will be notified on or about Friday, May 1, 2026, by phone and/or email, and may be required to execute and return an affidavit of eligibility, a liability release and, where lawful, a publicity release within seven (7) days of date of issuance. If such documents are not returned within the specified time period, a prize or prize notification is returned as undeliverable, Sponsor is unable to contact a potential winner or a potential winner is not in compliance with these Official Rules, prize will be forfeited and, at Sponsor’s discretion, an alternate winner selected.
