

Integra First Federal Credit Union Car Detailing Giveaway Official Rules

THE ODDS OF WINNING DEPEND UPON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED DURING THE SWEEPSTAKES PERIOD.

Integra First Federal Credit Union's ICU Day Giveaway (**the "Sweepstakes"**) starts on Monday, Sept. 1, 2025, at 8 a.m. ("CT") and ends on Tuesday, Sept. 30, 2025, at 11:59 p.m. Central Time ("CT") (**"Sweepstakes Period"**) or when the online loan applications reach 100 entries.

ELIGIBILITY: Open only to legal residents of the fifty (50) United States and the District of Columbia, 18 years of age or older at time of entry. Void where prohibited.
